- Payment.** Credit Card Authorization form, Certified Check, or Money Order payable to VisaHQ.com.
- Return mailer.** Prepaid self-addressed return label or payment for FedEx.

You will also need to provide proof of the host's status in Fiji ie. copy of their Fiji passport's information page, or, if they are not a citizen of Fiji, copies of their Fiji residence permit and their national passport's information pages.
